REQUIRED DOCUMENTS FOR APPROVAL

GOVERNMENT ISSUED DOCUMENTATION: (Original Copy will be verified)

- Valid state-issued identification (e.g., Driver License, ID card, Passport)
- For undocumented vessels: Copy of Valid Vessel Certificate of Ownership and/or Current Vessel Registration issued by DMV.
- For documented vessels: Valid Vessel Documentation Certificate issued by US Coast Guard.

INSURANCE DOCUMENTATION:

- Evidence of current vessel insurance with a per occurrence coverage limit of at least \$500,000 in liability and \$500,000.00 in pollution coverage.
- Coverage update issued by vessel insurance company indicating that the following entities are listed as additional insured interest:
 1. Pacific Marina Venture, LLC – 4655 Admiralty Way, MDR CA 90292
 2. Pacific Ocean Management, LLC – 13737 Fiji Way Suite C-10, MDR CA 90292
 3. LA County DBH – 13837 Fiji Way, MDR CA 90292

MARINE SURVEY:

- For vessels with wooden hulls: An out of water marine survey conducted by a SAMS, NAMS, ACMS, USSA or IIMS marine surveyor within the past 12 months.
- For all other vessels 10 years and older: A marine survey conducted by a SAMS, NAMS, ACMS, USSA or IIMS marine surveyor within the last 3 years.

PHOTOS WITH THESE SPECIFICATIONS: (bow, stern and sides)

- For all vessels: Vessel name or any identifying physical characteristics of your vessel in full color.
- For undocumented vessels only:
 1. The CF number must be legible and must match your CA DMV issued ownership and number certification.
 2. Vessel's current CA DMV issued registration sticker.
